## **GENERAL RULES**

1. All Members on club property must wear their current membership card in plain view. Exceptions are activities that are open to the public. You are required to show the card to any member verifying your status.

2. Personal Responsibility: Each member shall be fully responsible for his/her actions, as well as the actions of invited family members and guests. See "Guests and Children" section under Club Ops

3. Club facilities are for use only by paid-up members in good standing. Invited family members and guests must be accompanied by and in the presence of the member. Family members are spouse and children under the age of 18.

4. Infractions of General or Range Regulations shall be reported to a Member of the Board of Directors. A violation can result in any listed disciplinary action in accordance with the by-laws or in prosecution.

5. No one "under the influence of alcohol or drugs" will be allowed to handle firearms while on club property. See Gun Handling Rules item 22.

6. Designated ranges are closed for scheduled matches. Consult Match Schedule in the RRRC newsletter and the RRRC web site www.roanokerifle.com, for details. Changes will be posted on the Website when possible.

7. The speed limit is 10 mph on Gun Club Drive and on club roads. Slower speed may be necessary to avoid dust.

8. All vehicles shall be parked in the designated parking area, unless authorized by the RRRC management or responsible match director.

9. All scheduled event use of the range shall take precedence over any individual or personal activity unless sharing the range is approved by match director.

10. Personal targets may be used but cannot include targets that are glass, explosive targets, and any other exotic items may not define as targets at any time without the permission of RRRC management and then only in a closed range or match scenario.

11. Smoking: No smoking inside any of the buildings. No smoking on the firing line. Smoking is permitted in any open air area behind the firing line. This includes the front porch of the skeet shack and any area except the concrete pads on the skeet and trap fields, the area 10 feet back from the front of the concrete pads on ranges A and C and the space under the shelter on range B. Smokers are asked to be respectful of other members when present. Smoking disposal containers will be provided at each range along with fire extinguishers.

12. Eating and drinking of non-alcoholic beverages is permitted on all ranges but is not recommended by RRRC due to possible lead contamination.

13. Personal steel targets may be used subject to the following guidelines: • Pistol and Shotgun with bird shot- Steel target will be placed no closer than 10 yards from the firing line (Maximum 1,500 fps lead ammo).

• Twenty-two rim fire rifle, no closer than 50 yards from the firing line.

• Rifle and shotgun with slug- no closer than 100 yards from the firing line.

• Exceptions include holders that angle the target surface and directing splatter down and under direction of specific match conditions and director (i.e., cowboy action and the SASS Shooter's Handbook). (added 3/2021)

14. Hand-held skeet throwers are not to be used on any of the ranges.

## Firearm and Ammunition Restrictions:

Handguns- no caliber restrictions

Rifles (shoulder fired) – No restrictions. Bump stocks are not allowed.

Muzzle loaders – No restrictions. Those individuals shooting muzzle loaders must check in with the RSO for bench assignments so as to not interfere with other shooters with the smoke discharge when firing.

Shotguns – No restrictions.

Incendiary and armor piercing ammunition is prohibited. This includes tracers and any explosive devices.

## **Class 3 Devices**

All class three devices require a special permit issued by the RRRC BOD in addition to the Federal Permit which is required by law. Class 3 weapons as defined by the NFA and CFR, Part 479 include but are not limited to the following:

Machine guns, Silencers and any part designed and intended for fabricating a silencer, short barreled rifles and shotguns and destructive devices as defined by ATFE.

If you do not have the required federal documentation and RRRC special permit, do not bring class 3 devices to RRRC property. Violations of this may result in expulsion from the club
